



OFFICE OF THE PRESIDENT - FOR IMMEDIATE ENACTMENT

A LAW

For the purpose of determining government appropriations for the financial period February 2019 through February 2020

ARTICLE I: INITIAL PROVISIO

- 1) All legislation passed after this Law, including presidential decrees, statutory instruments and acts of the Presidential Advisory Council must place titles next to its Articles in order to inform readers of the article's substantive content.

ARTICLE II: DEFINITIONS

- 1) For the purposes of this Law, the term "appropriations" carries the same meaning it carries in the Finance Law.
- 2) For the purposes of this Law, the terms "obligated" and "unobligated" carry the same meaning they carry in the Finance Law.

ARTICLE III: APPROPRIATIONS FOR THE DEPARTMENT OF STATE

- 1) For the operation of the Department of State at large, £0GBP is appropriated.
- 2) For the operation of the Homeland Security Office, £0GBP is appropriated.
- 3) For the operation of the Foreign Travel Advisory Service, £0GBP is appropriated.
- 4) For the operation of the Levaria Compliance Division, £0GBP is appropriated.
- 5) For the operation of the Florentine Liaison Agency, £0GBP is appropriated.
- 6) For the operation of the Office of the GUM Envoy, £0GBP is appropriated.
- 7) For the operation of the Office of the MSB Envoy, £0GBP is appropriated.

ARTICLE IV: APPROPRIATIONS FOR THE DEPARTMENT OF THE INTERIOR

- 1) For the operation of the Department of the Interior at large, £0GBP is appropriated.
- 2) For the operation of the Federal Elections and Referendums Commission, £0GBP is appropriated.
- 3) For the operation of the Federal Architectural Regulatory Board, £0GBP is appropriated.
- 4) For the operation of the Federal Entertainment Software Board, £0GBP is appropriated.
- 5) For the operation of the Federal Patents and Trademarks Bureau, £0GBP is appropriated.
- 6) For the operation of the National Emergency Management Agency, £0GBP is appropriated.
- 7) For the operation of the Property Registrar, £0GBP is appropriated.
- 8) For the operation of the Bureau of Land Management, £0GBP is appropriated.
- 9) For the operation of the Office of Bureaucratic Diagramming, £0GBP is appropriated.
- 10) For the operation of the Office of National Statistics, £0GBP is appropriated.
- 11) For the operation of the Office for Naturalisation, £0GBP is appropriated.
- 12) For the operation of the Presidential Decree Publishing Agency (otherwise known by its trading name, "From the President's Desk"), £0GBP is appropriated.
- 13) For the operation of the Amissopian Enquirer, £0GBP is appropriated.

ARTICLE V: APPROPRIATIONS FOR THE DEPARTMENT OF JUSTICE

- 1) For the operation of the Department of Justice at large, £0GBP is appropriated.
- 2) For the operation of the Federal Police, £0GBP is appropriated.
- 3) For the operation of the Extradition Office, £0GBP is appropriated.
- 4) For the operation of the Lake Venom Presidential Commission, £0GBP is appropriated.



ARTICLE VI: APPROPRIATIONS FOR THE DEPARTMENT OF THE TREASURY

- 1) For the operation of the Department of the Treasury at large, £0GBP is appropriated.

ARTICLE VII: APPROPRIATIONS FOR THE DEPARTMENT OF INTELLIGENCE

- 1) For the operation of the Department of Intelligence at large, £0GBP is appropriated.

ARTICLE VIII: APPROPRIATIONS FOR THE DEPARTMENT OF LOCAL GOVERNMENT

- 1) For the operation of the Department of Local Government at large, £0GBP is appropriated.

ARTICLE IX: APPROPRIATIONS FOR THE DEPARTMENT OF TRANSPORTATION

- 1) For the operation of the Department of Transportation at large, £0GBP is appropriated.

ARTICLE X: APPROPRIATIONS FOR THE DEPARTMENT OF TRADE

- 1) For the operation of the Department of Trade, £0GBP is appropriated.
- 2) For the operation of the Customs Union Compliance Bureau, £0GBP is appropriated.

ARTICLE XI: APPROPRIATIONS FOR THE DEPARTMENT OF CULTURE

- 1) For the operation of the Department of Culture at large, £0GBP is appropriated.
- 2) For the operation of the Amissopian Conlang Institute, £0GBP is appropriated.
- 3) For the operation of the Whestcorean Heritage Institute, £0GBP is appropriated.
- 4) For the operation of the Universal Triumvirate Heritage Institute, £0GBP is appropriated.
- 5) For the operation of the various Micronational Repositories, £0GBP is appropriated.

ARTICLE XII: APPROPRIATIONS FOR THE EXECUTIVE OFFICE OF THE PRESIDENT

- 1) For the operation of the Executive Office of the President at large, £0GBP is appropriated.
- 2) For the operation of the Law Commission, £0GBP is appropriated.
- 3) For the operation of the Presidential Library, £20GBP is appropriated.

ARTICLE XIII: ADDITIONAL UNOBLIGATED FUNDING

- 1) An additional £20GBP is delivered to the Department of the Treasury to be made available for ad hoc government spending.

ARTICLE XIV: SOURCES OF FUNDING

- 1) The overall government budget of £40GBP for the period FP2019/2020 shall be sourced as follows:
 - a. 100% (or £40GBP) in donated funds from the President.

ARTICLE XV: AMENDMENTS TO THIS APPROPRIATIONS LAW

- 1) This Law may be amended as and when necessary when budgets require increase or to make arrangements for departments and federal agencies that do not currently exist.

ARTICLE XVI: EXTENT, COMMENCEMENT AND SHORT TITLE

1. This law shall take effect upon presidential signature.
2. This law shall affect the entire Federation.
3. This law may be referred to in short hand as the Appropriations Law 2019.
